NOTICE TO APPLICANT: In the event and applicant and/or his representative fail to appear before the Board of Adjustment or Zoning Commission or the Board of Trustees for hearings as provided in Village Ordinances at the time advertised for said hearings, said request may be stricken from the agenda.
