# News



### What a year!

The Trustees are always busy, but this year has really had them hopping. COVID-19 has forced everyone to make changes to adapt to new ways of living their lives while still performing required duties; at work, at home, at school, at church and with their families. The Board has worked diligently to function as normally as possible, abiding by social distancing and safety precautions, as they take care of all tasks and matters that come before them.

On August 4, 2020 the Primary Election was held. The ballot included Proposition A, asking qualified voters to impose a 1/2 of 1% Sales Tax for Public Safety. The Jasper County Clerk Charlie Davis reported these results:

Yes 135 (65.22%) No 72 (34.78%)

The new sales tax will go into effect January 1, 2021. As promised to Village Residents, a request has been made to the Jasper County Sheriff's Office to assign a third full time officer to Airport Drive. The third officer is expected to start mid-November. The estimated cost for three officers for 2021 is \$222,133.14.

The Carl Junction Fire Protection District has provided their annual cost for services in 2021. The Jasper County Clerk suggested they use only the personal property valuations in their protection district, instead of county wide. The assessed amount was 12% less than the 2020 amount. Airport Drive will pay the CJ Fire Protection District \$81,889.67 for fire and emergency medical services in 2021. The Trustees requested quotes from the cities of Joplin and Webb City for fire and emergency medical services, but voted to stay with the Carl Junction Fire Protection District.

Village Attorney Derek Snyder is working with the attorney for the Jasper County Public Water System District #1 on an intergovernmental agreement. The Trustees are working on options to try to improve the water system and to be able to install fire hydrants in areas where there are none, for improved fire protection in Airport Drive.

Phase One of the Street Overlay Project is completed. The Board plans to overlay the remaining streets in 2021. There is also a project planned to widen Bland Avenue east of Main Street Road. This project includes increasing the turning radius of the intersection of Elm Street and Bland Avenue.



### **New Sewer Rates**

After months of reviewing information, the Trustees adopted Ordinance 16-20 on September 24, 2020, to increase sewer rates charged to Airport Drive's sewer users. Trustee Terry Myers assisted Engineer Jerald Norton to calculate the new rates. The City of Carl Junction increased the rate charged to Airport Drive by 7.7%. To match the increase taken by Carl Junction, the Trustees increased the amount charged per thousand gallons of water used from \$2.90 to \$3.25. The base rates charged remained unchanged and are listed below:

The average water usage for residences is 3679 gallons per month. The monthly bill for that usage is \$41.26, an increase of \$1.29. Just a reminder, if you have had a water leak, filled a pool, or had an unusually high water bill, especially in the months of January, February or March, please call the Village Office and let us know.

Carl Junction Fire Protection District would like to remind everyone to have their **house numbers on their homes**. It helps emergency personnel identify homes more quickly in emergencies.

The Mense CPA Firm, LLC has completed a Financial Statement for the first six months of 2020. See page 6 for the statement.

Self-response and field date collection operations for the **2020 Census** ended October 15, 2020. The Census Bureau reported 99.9% of housing units had been accounted for in the 2020 Census.

With the passage of Proposition A in the August 4, 2020 election, the **Sales Tax Rate** will change to **7.45% on January 1, 2021** in Airport Drive. The General Fund will receive 1% and the Capital Fund and Safety Tax Fund will each receive .5%.

We have added a **calendar to our website**. Check out upcoming meetings and events, such as leaf pick up, election dates, and office closures. If anyone has suggestions for additional items or functions they would like to see on the website, let us know!

### WHO WANTS TO BE A TRUSTEE?

The General Municipal Election will be held on Tuesday, April 6, 2021 at the Village of Airport Drive Municipal Building. On that date, terms will expire for Trustees Terry Myers and Ray Bryant. If you would like to serve your community as a Trustee, filing will begin on Tuesday, December 15, 2020 at 8:00 a.m. at the Village Municipal Building at 25150 Demott Drive, Joplin, Missouri. Filing will end on Tuesday, January 19, 2021 at 5:00 p.m. The following are the requirements to file for Trustee: You must be a United States Citizen, a resident of Airport Drive for at least one year prior to the election, and twenty one years of age or older. Please bring your ID when filing. Candidates must file an affidavit declaring that they are not delinquent in filing or payment of state taxes, personal property taxes, municipal taxes or real property taxes with the Missouri Department of Revenue.

Trustees are elected to two year terms and serve the Village at large. They meet on the fourth Thursday of each month, unless posted otherwise; and for special meetings as needed.

The Trustee position is a non-compensated job. These residents must make time to meet at least once a month to serve the community. They work as a group to create policies and make decisions for the benefit of the Village.

The Budget Committee met on October 21<sup>st</sup> to create a proposed Budget for 2021. A great big Thank you to Residents Mark Johnson, Janie Liles, Carolyn Longerot and Mike Warman for serving on the committee!





Republic Services contract for collection and disposal of residential trash will end on December 31, 2020. During the September 24, 2020 Board of Trustees Meeting, bids for service from WCA - Joplin Hauling and Republic Services were opened and reviewed. The Trustees motioned to accept the bid from Republic Services for a five year contract to begin January 1, 2021. The cost for residential service in 2021 will be \$10.70 per month. Annual adjustments will be based on the Consumer Price Index for water, sewer and trash, not to exceed a 3% increase.

### Internet Options

Internet options for residents and businesses have been limited for quite a while. Mediacom offers cable, internet and phone service is our area, but there are a lot of service interruptions. Resident Jeff Howe wanted to let other residents know that Mediacom is supposed to reimburse their customers for any service outages. Be to sure contact Mediacom at 1-855-633-4226 any time you lose service to request a refund for the outage.





What are other options? Wisper and Aire Internet offer wireless services. Their phone numbers are listed on page 6. Craw-Kan Telephone from Girard Kansas offers fiber internet and serves an area around Asbury and to the east. They don't foresee coming to this area in the next year; but said anyone interested in service can to go to their website and fill out the form to request service. They will track the number of requests they receive for service in our area. If enough residents show interest, they could starting installing lines towards our area.

No Tree Limbs, Trash or Rocks
Leaves must be out to the road right-of-way
(Within 5 feet of the road)

Leaves must be in wind rows

(A row about 2-3 feet wide and then as long as it needs to be)

Do not cover Water Meter Lids or Manholes

Do not mulch leaves

No bagged leaves, this is a vacuum system

If your leaves are not picked up by the end of the day on December 14th, please call the office. We will contact Carl Junction to pick them up.
